#### Galatians 2:20

When you become a Christ follower an <u>exchange</u> is made: He gives His eternal life to you, and you give your life to Him! When you become a follower of Jesus, you start living a life that is "on loan" to you from the Lord.

## I. Be Realistic about Ownership.

The Master, who represents Jesus in this story, distributes His <u>resources</u> to His servants to use for His purposes.

When you are the manager of someone else's stuff you're not an owner, you're a steward, an accountable manager.

1 Chronicles 29:11-12; Psalm 24:1

## Three principles about my stewardship:

- Everything belongs to God.
- Everything <u>comes</u> from God.
- Everything is distributed by God.

Just because something is in your possession, doesn't mean it is your possession.

#### II. Be Pro-active with Your Stewardship.

- Stewardships are given for a purpose.
- Stewardships are given with an expectation.

#### III. Be Aware of Stewardship Opportunities.

- · Starter Level Giving.
- Crisis Driven Giving.
- Systematic, Obedient Giving.
- Spirit Directed Giving.

Biblical stewardship is not about giving God anything. It's about <u>returning</u> to Him what He has entrusted to me and then experiencing His blessing. *Malachi* 3:10; *Luke* 6:38

You will never come out second by putting Jesus first!

- If you give the standard gift...you get the standard blessing.
- If you give generously...you'll be rewarded generously!

Giving generously is a spiritual discipline that practically affects your world.

There are present and eternal <u>rewards</u> for those who live a life on loan from God.
